Proposed Amendment #8 to the FY 2018-2021 Transportation Improvement Program as approved by the Transportation Improvement Program Committee and Transportation Council is now presented to the Board of Trustees for consideration.

1. Modify one project in the FY 2018-2021 TIP at the request of TARTA. This project does not utilize TMACOG-managed funds. The project is:

- a. TARTA – Downtown Transit Hub  
PID 90125                           \$62,936 – FTA/Local – FY 2018 – CO  
ALI 11.34.02

The modification is changing the ALI Code from 11.33.02 to 11.34.02 as well as increasing the cost from \$25,000 to \$62,936.

2. Modify one project in the FY 2018-2021 TIP at the request of ODOT. This project does utilize TMACOG-managed funds. The project is:

- a. Lucas County – LUC Kilburn Rd Bike Lanes  
PID 98999                           \$99,000 – Federal/State/Local – FY 2019 - RW

This modification is reflecting the current estimate for RW. This project received a total of \$208,000 in TA funds to be used on RW and RW services. The RW services under the PE phase utilized \$35,200. The current estimate for RW acquisition for TA funds is \$67,200. A total of \$105,600 of TA funds will be available if the RW estimates change.
