

FY 2018-2021 TIP Amendment #12 - STAFF REPORT

TOLEDO METROPOLITAN AREA COUNCIL OF GOVERNMENTS

Proposed Amendment #12 to the FY 2018-2021 Transportation Improvement Program as approved by the Transportation Improvement Program Committee and approved by the Transportation Council is now presented to the Executive Committee for consideration.

1. Modifies two projects in the FY 2018-2021 TIP at the request of ODOT. These projects do not utilize TMACOG-managed funds. The projects are:
 - a. ODOT – WOO SR 582 6.48 Widen
PID 81000 \$7,426,521 – Federal/State – FY 2019 – CO
The amendment is increasing the construction estimate from \$5,170,000 to \$7,426,521.
 - b. ODOT – LUC IR 475 Interchange and Widen Phase 3
PID 88084 \$41,550,000 – Federal/State/Local – FY 2020 – CO
The amendment is combining PIDs 88084 and 99737.
2. Modifies one project in the FY 2018-2021 TIP at the request of the City of Perrysburg. This project does utilize TMACOG-managed funds. The project is:
 - a. City of Perrysburg – WOO Maumee River MUP PH 3 & 4
PID 101863 \$1,115,528 – TA/Local – FY 2019 – CO
The amendment is splitting this project into two separate projects. PID 101863 will be phase 4 and PID 109388 will be phase 3.
3. Remove one project from the FY 2018-2021 TIP at the request of the Metroparks.
 - a. Metroparks – LUC Oak Openings Trail
PID 1047274 \$870,389 – TA/ Local – FY 2020 – CO

**A RESOLUTION OF THE

MAKING AMENDMENT NUMBER TWELVE
TO THE FY 2018-2021 TRANSPORTATION IMPROVEMENT PROGRAM**

WHEREAS, the Board of Trustees of the Toledo Metropolitan Area Council of Governments is designated as the Metropolitan Planning Organization by the Governor of Ohio in cooperation with local elected officials and is authorized to carry out the continuing, comprehensive, and coordinated transportation planning process for the Toledo area; and

WHEREAS, the FY 2018-2021 Transportation Improvement Program (TIP) was approved by the TMACOG Board of Trustees by Resolution Number 2017-09 on April 12, 2017; and amendments #1, #2, #3, #4, #5, #6, #7, #8, #9, #10, and #11 were previously approved; and

WHEREAS, it is necessary to modify three projects and delete one project in the local TIP; and

WHEREAS, the project addition in this resolution was approved by Transportation Improvement Committee on November 26, 2018, and was approved by the Transportation Council on December 5, 2018; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOLEDO METROPOLITAN AREA COUNCIL OF GOVERNMENTS:

Section 6


