Minutes

1. Convene meeting/introductions

Ron Myers convened the meeting and the August meeting minutes were reviewed. A motion was made by Gary Stookey to accept the minutes and John Crandall seconded and the motion passed.

2. 2045 On the Move 2020 Update

- a. **Transportation 101** – Dana Doubler first went over the updates to the Task Force Schedule since the August meeting. Lisa Householder discussed the Functional Classification and NHS maps, along with updates to them. She then went over the Pavement Condition Rating map, Pavement Performance Measure map, and Bridge map. Lance Dasher presented maps which depict Level of Travel Time Reliability and Truck Travel Time Reliability for the planning region. Roger Streiffert presented maps related to the freight network, including the highway network, railway network, ports and airports, and truck volumes.
- b. **Pavement and Bridge Performance Measures** – Dana Doubler presented on the incorporation of performance measures and throughout the Transportation 101 presentations. The Pavement and Bridge measures were presented and indicate the percentage of “good” pavement and “poor” pavement on the NHS system. Ken Fallows made a motion to approve the targets and Kris Cousino seconded and the motion passed.
- c. **Travel Time Reliability Performance Measures** – Dana Doubler presented on the incorporation of performance measures and throughout the Transportation 101 presentations. The travel time reliability measures were presented, and measure how consistent roadways are in terms of their travel time. Kris Cousino made a motion to approve the targets and John Crandall seconded and the motion passed.

3. Next Steps

The next Task Force meeting will include the continuation of the “Transportation 101” overview in which staff will present information on the transportation network in our region. Meetings will also include scenario planning for land use and employment and discussion to update the transportation needs.

Erie St and Michigan St are finishing up, and mill and fill is wrapping up on Summit St. Jackson St should open back up end of October, then Jefferson will open up. Ron Myers from Lucas County informed everyone that McCord Rd north of Central to Woodlake will have a center island and the island will be in place by the end of the week.

Gary Stookey mentioned that Metroparks and the City of Toledo are starting the bikeshare program in Toledo, which will launch soon. He also talked about concerns over University of Toledo's scooters.
